- Call the ugly multiple contacts

# REVIEW OF LAST TRAINING (4 STATIONS)

## LINE JUDGE – HEATHER / ELLEN

- Warm up the eyes during team warmup
- Position during lineup check, flag/ball position, when to roll ball to ball shagger
- Presenting signal: make call, bring feet together/posture fully upright
- Duties/location during: TO, Injury,
   Deciding Set

- During match positioning:
  - Base Position
  - Slightly bent, wider stance
  - Crouched, more bend
  - BTBTTL (where to focus the eyes)
  - Inside out technique to see the gap

# REVIEW OF LAST TRAINING (4 STATIONS)

#### R2 RESPONSIBILITIES/MECHANICS – DANNY/LARRY/ELLEN

#### **Transitioning**

- To blocking side get there before the setter sets the ball
- Look through the net to see the 2<sup>nd</sup> contact
- Responsible for whistling when ball contacts or goes outside antenna

#### **TO** protocol:

 signal the TO and give the R1 the number of TO's used at shoulder height. No discrete showing of # of TOs

**TO and Sub protocol:** Try to do the Sub AFTER... at END of the TO

- Horn ends TO
- Given # of TOs to RI
- Double whistle for Sub....administer sub
- Give the court back to the RI

# REVIEW OF LAST TRAINING (4 STATIONS)

#### R2 RESPONSIBILITIES/MECHANICS – DANNY/LARRY/ELLEN

#### **Substitution protocol/technique**

- Double whistle
- One sub in zone at a time
- Both sides subbing, determine which side pauses while you administering the other team's sub
- Make subs wait until you release
  - If not, use whistle to get them to return until released.
- Before giving the court back take a quick scan to both benches (TO or other team subbing)

COACH in the sub zone or players not seating after being subbed out

- Walk Coach out of sub zone while using your arm/had to direct them to where they need to be
- Same technique for letting the coach know they need to stay 6ft back during play
- Use your arm/hand to direct them

## **LIBERO**

# RI ARM OUT TO BECKON SERVE ...EXCHANGE TAKES PLACE

- YUD
- After play has ended...next dead ball
- Either RI or R2 can initiate the YUD
- R2 make it gets recorded and inform the coach

# RI WHISTLES FOR SERVE ... EXCHANGE TAKES PLACE

- Illegal Alignment
  - called by R2 if on receiving team side
  - Called by R1 if on serving team side
- RI....Establish a routine to scan prior to initiating serve...and keep the same pace throughout the match

# LIBERO – INJURY TO LIBERO CASEBOOK PG 46 SITUATION 10.4.2.B AND C

#### **DURING PLAY – WHISTLE STOPS PLAY**

- Libero replaced by proper "replacement" player
- Coach wants a player #10 currently on the court to be the redesignated libero.
- Coach cannot sub #10 out but must wait for the next dead ball to sub for #10.
- NO Subs can be taken
- At next dead ball #8 subs for #10. The coach can call a TO to give #10 time to switch uniforms and at the end of the TO #10 (redesignated libero) can enter the set replacing anyone in the back row.

#### DURING DEAD BALL – END OF A RALLY

- Libero replaced by proper "replacement" player
- Coach wants a player #10 currently on the court to be the redesignated libero.
- Coach CAN sub #10 out but must wait for the next dead ball for #10 (redesignated libero) to replace anyone in back row.
- Additional substitutions can take place when #10 is subbed out.

# Some RI Responsibilities

The second referee stands outside the sideline and back from the standard at a distance that permits clear vision and freedom of movement. It is the responsibility of the second referee to assume a position that does not interfere with the players' legitimate effort to play the ball. The first referee depends on the second referee to watch for center line and net violations as well as whistling/signaling the ball out of bounds for an antenna fault while the first referee follows each contact of the ball to observe ball handling.

An additional responsibility for the second referee is to ensure that the head coach, when standing during play, maintains a position in the replacement zone no closer than 6 feet to the sideline.

The second referee shall assist with ball-handling violations only when they are clearly out of the first referee's view, such as when a player has his/her back to the first referee, plays a ball near the floor, etc. Informal signals should be used to communicate the violation to the first referee (see Informal Signals, Nos. 2, 3 and 5 in Officials' Manual). How these calls are to be communicated should be addressed in the referees' prematch conference.

It is important that the first referee makes good eye contact with the second referee and knows how they will communicate in advance. The first referee should anticipate when he/she may have been blocked out of properly observing a play.



# **Responsibilities During the Match**

First Referee (R1): Throughout the match the first referee maintains general supervisory control of the teams and other officials. He/she makes the final decision concerning matters not specifically covered by the rules or when there is a discrepancy between referees and line judges. The first referee may correct a confirmed error by a member of the officiating crew and cancel points, if appropriate, provided the correction is made prior to the contact of serve by the opposing team following a point. The first referee may also replace a scorer, libero tracker, timer or line judge who is not performing his/her duties properly.

Jurisdiction of the referees begins upon their arrival on the floor and extends through the second referee's verification of the final score of the match. The referees retain clerical authority over the contest through the completion of any reports, including those imposing disqualifications, that are responsive to actions occurring while the referees had jurisdiction.

The first referee's position throughout the match is on the referee's platform except possibly during a referee's time-out and during timed intermission. Unless necessary, the first referee shall remain on the referee's platform between sets. The first referee shall be responsible for seeing that a whistle is blown and visual signals given for all dead balls, faults, violations, penalties, time-outs, substitutions and serve. At times, it may be necessary to also verbalize the call.

R1 does NOT get off the stand

#### TIME-OUT

- Charged time-out. The second referee shall:
  - a. Recognize the request with two short whistles, display Signal 19, at shoulder height, and indicate to the first referee the number of time-outs each team has used;
  - b. Remind the timer to start the clock for one minute;
  - Check with the scorer to make sure the time-out is recorded on the scoresheet for the appropriate team;
  - d. Check the scoresheet for any individual score and team score discrepancies, and make sure the visible scoreboard agrees with the scoresheet;
  - Check with the libero tracker to confirm the status of the liberos on or off the court;
  - f. When 45 seconds have elapsed during the time-out, the second referee shall sound a double whistle to remind teams to return to the court. At 60 seconds, the timer shall sound the audio signal to end the time-out. For multiple courts, the second referee may end the time-out with a long whistle. The second referee indicates the number of time-outs used holding the signal with hands head high, informs the coach if two time-outs are used and gives ready-to-play signal to the first referee.

R2 – Number of TOs, location is shoulder height and visible to R1

R2 – End <u>of TO</u> location is hands head high

#### **INFORMAL OFFICIALS' SIGNALS**

As mentioned in the prematch section of the Manual, informal hand signals are used to enhance in-match communication between the two officials and between officials and coaches. How these calls are to be communicated should be addressed in the referees' prematch conference. Such additional signals might include:

#### **SECOND REFEREE COMMUNICATION TO FIRST REFEREE**

- Set/Match Point: Place the index finger flat against the shoulder closest to the team that has set point.
- 2. Four Hits: Discreetly give four-hit signal in front of chest.
- 3. Identifying Possible Back-Row Player Violation: Discreetly show illegal attacker signal or illegal block signal in middle of chest.
- 4. Position of Setter Prior to Serve: Second referee uses discreet signal with his/her hand on each leg, midsection or chest to identify position (front row or back row) of each team's setter. Use of and type of signal may be decided in prematch discussion between the referees. Examples are:
  - 2 fingers = back-row setter
  - 1 finger = front row setter
  - Little finger = back-row setter
  - Thumb = front row setter

These are not used on every rally, only when needed for improved communication.

5. Illegal Hit: The second referee is to assist the first referee in calling illegal hits by use of discreet signals in front of the chest. The second referee shall assist with ball-handling violations which are out of the first referee's view. The second referee does not whistle, but will use the discreet signal to the first referee. If the first referee passes on the signal, the second referee drops the signal.

- 6. Ready to Play: The second referee indicates to the first referee readiness to resume play with an extended arm and open hand (outside arm/hand preferred) while positioned on the receiving team's side, facing the first referee while making eye contact.
- 7. Net Fault Player Identification: Hand of outstretched arm on the side of the net of team at fault. Indicate the player at fault by number. Second referee signals first referee with the hand on the side at fault for player numbers 5 or less. For numbers 6-9, the right hand is the base hand; No. 10: right hand closed fist; Nos. 11-19: right fist then digits successively; Nos. 20 or more: first digit with right hand and second digit with left or both hands if necessary. The second referee and first referee signal offender's number. Guidance is offered on when/how to signal player numbers on pages 97-98.
- 8. Antenna Fault Team Identification: When opposing players at the net contact the ball in quick succession and the ball touches an antenna, it may be appropriate for the second referee to assist the first referee by indicating which team caused the ball to contact the antenna. To clarify this fault, one arm is extended, open hand, toward the team at fault. The first referee signals out-of-bounds and need not mirror which team is at fault.
- 9. Out, Off You: The second referee indicates to the first referee with Signal 13 "Out-of-Bounds/Antenna Violation," releases the signal and then follows with an open hand, extend arm closest to the team that forced the ball into the antenna. (If needed, the R2 may lead the R1 by awarding point.)

## SIGNAL MECHANICS....WHEN TO USE "OUT" VS "TOUCH"

Ist, 2<sup>nd</sup>, 3<sup>rd</sup> ball that is played by a team and lands out or flies over the bench/officials table and into the bleachers or hits a wall on the same side as team that last contacted it...
TOUCH.

 Remember - any 3<sup>rd</sup> contact that hits the ceiling....OUT Ist, 2<sup>nd</sup>, 3<sup>rd</sup>, ball played by a team and then contacts the net AND then lands out of bounds on same side as team that sent the ball into the net....OUT

- Use "out off you" signal to clarify which team last touched the ball
- Similar to indicating which team last contacted the antennae which it is a bang, bang play near antenna
- Think...The ball contacted EQUIPMENT and went out so "OUT". Ball contacts the referee stand...OUT
